#### **Agenda and Minutes**

#### 1. Call to Order

Meeting was called to order by Jamie Platt at 7:34 pm

#### 2. Approval of Agenda

Agenda was approved by all.

#### 3. Approval of Minutes from 2024 Fall Meeting

Minutes from Fall Meeting were approved by all.

#### 4. Financial Report

Budget will be discussed later in the meeting. Treasurer report was posted online. All LSC's are current. Open Water, \$5,000 and Athlete Summit expenses coming up. Report was approved.

#### 5. Report of Officers

### a. Zone Directors Report - Jamie Platt & Tom Ugast

Report from Zone Directors was posted online. Zone Director Council is working on building out and structure, collaborating with CEO task force. Will have a summit September 25-27 in conjunction with USAS Annual Meeting and Golden Goggles in Denver. Jamie mentioned change in Team Services and LSC's at USA Swimming – Split - Beth and Nate will work with teams and Karin with LSC's. Report was approved.

### b. Technical Planning Report - Brittany Glass

Jamie thanked Brittany Glass for stepping in for Pete Barry who has medical issues. Report is posted online. Brittany reported that the Tech Planning committee met and there will be no changes to time standards for the LC Championship meets. Recommended 2 technical changes – 1: Age Group LC Zones – instead of awards to add a B final and 2. LC Senior Zones – change D final from 18 and Under to 16 and under. A motion was made for Age Group Zones to add a B final at LC Age Group Championships –

motion was seconded, discussion followed.

A **motion** was also made for Senior Zones to have the D finals to change from 18 & Under to 16 & Under. Motion was seconded.

LSC's were sent to breakout rooms to decide on the vote.

Both motions passed. Technical Planning report was approved.

Zone Directors will form a task force for Sectional meet decisions.



#### c. Zone Championship Coordinator Report - Tim Husson

Zone Championship report is posted online. Meet bids are due by the fall for 2027. Report was approved.

#### d. Athlete Representative Report - TJ Walsh

TJ reported that information for the athlete summit went out to General Chairs and athlete reps for each lsc. More discussion on this in new business. They have been doing check ins with athlete reps and have had their first quarter call in March. 2<sup>nd</sup> quarter call coming up. Report is posted online. Report was approved.

#### e. Age Group Chair Report - John Fedena

John reported that Age Group Chairs from the 4 zones have been meeting over the last 18 months with Dana from USAS. Report is posted. Report was approved.

#### f. Diversity, Equity, and Inclusion Report - Nadine Johnson-Jesionek

Nadine reported that the DEI committee is trying to get back a quorum and continue meeting.

Next meeting June 1 at 7:00 pm. Report was approved.

#### g. Officials Chair Report - Genny Kimbel

Genny reported that the Zone is holding steady with officials and meets are well staffed. Leadership for the meets came from 4 different LSC's. Eastern Zone LSC officials are consistently picked for National Meets. Report is posted. Report was approved.

#### h. Safe Sport Chair Report – Will Gallagher

#### Disability Swimming Coordinator Report – Elizabeth Jester

Southern Zone did a disability clinic — Elizabeth hopes to do one in the Eastern Zone in the fall. The committee is working to have standardized language in meet announcements across the country, including language that defines what a disability is (which is up for approval at USAS). There are also updated parallel time standards for Swimmers with Disabilities, which are posted on USA Swimming and the Zone website. This should be updated every quad. Report was approved.

#### a. Budget

Mary Turner explained we have \$58,000 in our account but we are not spending from the categories we have budgeted for. We are receiving dues from each LSC. An Athlete Summit has been planned for June 26-29 at Catholic University in DC. 3 athletes and 1 chaperone from each LSC is invited to attend. Athletes can be current or newly elected reps or someone from the LSC that would like to get involved. They realize it is short notice, but the opportunity is there. All is ready to go — workshops, speakers and contracts. Cost - \$200 per athlete with LSC providing transportation. Cut off date is June 13<sup>th</sup>. Discussion followed.

The mission of the Eastern Zone is to develop a unified organization designed to work in cooperation with the LSCs to support and promote the Eastern Zone Swimming Membership.

#### Coach and Non-Coach Zone Directors Report

#### Zone Directors Council (ZDC)

The Zone Directors Council (ZDC) is a representative body comprised of the elected Coach Director, Non-Coach Director, and Athlete Director from each of USA Swimming's four geographic Zones. In addition to these voting members, the Junior Athlete Representatives from each Zone are invited to participate in Council discussions and initiatives.

The Council convenes on a monthly basis in coordination with designated staff members from USA Swimming, Board Liaison Kathleen Prindle, and other liaisons appointed to support communication and collaboration between the ZDC and other USAS governance entities. These regular meetings are to facilitate progress on strategic priorities, discuss shared concerns across the Zones, and advance initiatives in alignment with the broader mission and vision of USA Swimming.

Over the past eight months, the primary focus of the ZDC has been the continued refinement and formalization of the Council's structure, responsibilities, and operating procedures. This work has included the development of internal guiding documents, the clarification of the Council's role within the national governance framework, and the establishment of more consistent mechanisms for inter-Council and inter-Committee communication.

In support of USA Swimming's broader organizational goals, the ZDC has played an active role in several important projects, including:

- CEO Search Task Force The Council provided feedback and representation to ensure that Zones, Clubs and local perspectives were considered during the executive search process.
- LSC Leaders Survey The ZDC contributed to the design and dissemination of a national survey aimed at gathering insight from LSC leadership, the results of which are intended to guide future strategic planning and support services.

Committee and Council Collaboration Plan – The ZDC has been working in partnership
with USA Swimming staff to develop a structured approach for improved alignment and
coordination among standing Committees and Councils. This effort seeks to increase
transparency, reduce duplication, and strengthen the impact of volunteer leadership at
all levels.

The ZDC maintains a liaison to the Coaches Advisory Council (CAC), ensuring that the Council remains informed of coaching priorities and perspectives. Additionally, the ZDC fulfills its reporting obligation to the USA Swimming Board of Directors by presenting formal updates twice annually. These updates include summaries of ongoing projects, recommendations for Board consideration, and feedback from the Zones. The ZDC organizes and facilitates a "Meet the Candidates" session during Board election cycles and participates in the annual review of proposed legislation.

#### **USA Swimming Summit and Annual Business Meeting (ABM)**

Looking ahead, the 2025 USA Swimming Summit is scheduled to take place from September 25 to 27, 2025, in Denver, Colorado. This national leadership event will offer a range of professional development and strategic engagement sessions tailored to various LSC leadership roles. Planned tracks include programming for LSC General Chairs, Officials Chairs, Safe Sport Chairs, Coach Representatives, and Athlete Representatives to the Board.

In addition to the structured tracks, dedicated time will be reserved within the Summit schedule for Zone meetings, providing an important forum for our collaboration, planning, and the exchange of ideas. The Summit will culminate with the Annual Business Meeting (ABM), which will take place on Saturday, September 27. The ABM is a critical governance event during which elections, policy matters, legislation, and organizational priorities are formally reviewed and acted upon by USA Swimming's House of Delegates.

Following the ABM, the USA Swimming Foundation will host the Annual Golden Goggles Awards on Saturday evening at the Denver Art Museum. This prestigious event celebrates excellence in American swimming and honors athletes, coaches, and contributors who have made a significant impact in the sport. Tickets and table sponsorship options will be available to individuals as well as to LSCs, offering an opportunity for community celebration and recognition.

# **Site Feedback**

In March, we hosted a large meet with 929 athletes (539 men, 390 women) from 107 teams. Preliminary sessions were run on a 12-lane course to keep the length around 4 hours, including time trials. Officials efficiently managed the 12 lanes during prelims. The pool was converted to 9 lanes for evening finals. The meet saw 9 eastern zone short course records broken, 22 national qualifying times, 68 junior national qualifying times, and 519 futures cuts achieved.

#### Michael Cleary, Meet Referee

I felt the meet went well. Excellent staff all the way around. Having 12 lanes for prelims was new to me but we had the officials to cover and helped us keep to a good timeline. Really enjoyed my time at the meet.

#### Eastern Zone South Speedo Sectional Meet 2025, Christiansburg, VA

#### Mary Turner, Co-Meet Director:

As you know, the meet was under-subscribed, and I think the officials did a great job and attendees seemed to be happy with the meet.

One thing that we continue to have problems with is the AM/PM designation for Sunday relays. No matter how much the requirement is publicized, teams don't indicate their preference and then come begging on Sunday morning to move to AM because they got seeded at night. And we fix it! We either need to swim all relays in the morning on Sunday or stop accommodating requests to move. Another option would be to offer AM/PM for all relays throughout the meet and then folks might get used to the process. My preference, however, is to swim all Sunday relays in prelims.

#### John Avelis, Administrative Referee:

One issue from Sunday - despite frequent reminders, a lot of coaches still didn't realize that not specifying Sunday AM relay preference would put their relay swimmers in the finals session, which caused a lot of confusion on Sunday. Some possible solutions -

Require teams to declare AM/PM preference for all Sunday relays (I believe it's required for distance but not relays). Next time I'm an AR I'll do this on my own. It does require admin to be proactive.

Move to one heat of relays at Sunday finals - we had maybe 10-11 PM relay entries on Sunday, when it was all said and done? When I looked at the 2024 meet database, I think they ended up putting this in place.

Move ALL Sunday relay heats to AM; not the best solution for teams who come prepared to swim the whole meet but eliminates the issue.

I did hear from a coach who pointed out that there weren't a lot of new best times being set - but I can't recall if his solution was building in breaks to get swimmers more rest between events, or something more structural.

I know we looked at time between events closely for prelims, but I think it ended up an issue at finals - the same swimmers making finals in a lot of events. Not sure if that's something that can be addressed in the technical planning, or if it was because of the size of the meet.

Just to emphasize a positive - facility and meet directors were flawless, as I'd expect from folks who've run that meet for so long.

Jim Stromski, Meet Referee: Though the facility staff was great as John mentioned, I think the facility itself and some of the equipment used is in need of upgrades. I thought that the air quality, even when first walking on deck in the morning before the athletes, coaches, etc. arrived, the climate was very warm and humid (maybe that's the NYer in me talking?). It's my understanding, however, that the facility is going to be shut down for a while at some point this summer for a major ventilation upgrade, so that would resolve that issue.

We had approximately 420 athletes attend the meet, which was nice, but probably should have been better. Talking with Mary, she said that another meet of similar format was allowed to run in eastern VA during the same timeframe which she believed siphon ed off athletes that otherwise would have attended. Maybe an entry restriction of some sort during Speedo weekends that an athlete cannot swim an event for which he or she has a Speedo qualifying time at another meet?

To John's points,..

I think the relay problem is more of a coach education thing. The ability to declare Sunday AM preference was in the meet announcement and John covered it during his portion of the pre-meet Coach Meeting. We, as in the Meet Committee, can do everything possible to make information available and remind people, but ultimately, it's the coach's responsibility to know what's in the meet announcement.

I don't know what the 'normal' percentage of best times for a meet should be, but below is a line from the Meet Summary report that Mary sent to me post meet:

Women Men Relays Total Improved Times: 239 33% 422 42% 94 45% 755 39%

Those percentages seem pretty good to me and may have been just the perception of that coach. On the other hand, I did notice the same names appearing a \*lot\* during Finals, specifically during Sunday finals. It's possible that we just had a couple of really good athletes that excel in various strokes, or it could be a function of not having a larger number of athletes participating in the meet.

#### 2025 Speedo LC Sectionals, Buffalo, NY

#### Erika Livingston, Meet Referee

- There was no mention of an awards ceremony in the meet announcement, but TJ received the podium and back drop from USAS days before the meet. It would be nice to include an award ceremony after individual events. We created a sample timeline with awards, but it added an hour to the session. So, we didn't do it.
  - Suggestions:
    - The finals start session should begin one hour earlier to accommodate individual athlete awards.
    - Given the size of the meet, I think that there should be an option for an hour earlier Finals start.
- Officials. The host club LSC Officials chair should be identified as soon as the application to officiate is opened. When the OQM sanction was posted, I reached out immediately to the NI LSC Officials Chair Bob Nicita. He answered a few questions earlier on, but when I became increasingly desperate for officials, he did not respond. Within a week of the meet, I discovered that Leo Gibbons was the club's officials' chair. Leo helped to recruit some locals which prevented our need to use the Off DR/Off SR as S&T officials.
  - o Kudos to Leo for getting some locals out. In addition to Linda, there were 5 PVS officials who I recruited and one (ReNaye Davis) from VA. Their participation was extremely helpful.
  - We had a good representation from most LSCs. I wish that we had more local officials, but I was told that most were in Ithaca.
  - o Suggestion:
    - The LSC Chair should do more to assist with staffing the meet.

### **Proposal to the Eastern Zone 2025 Spring Meeting**

#### **Proposal:**

The Eastern Zone shall reimburse the host of a Zone sponsored meet up to \$1,000 per OQM (Officials Qualifying Meet) meet for travel and lodging expenses associated with bringing a National Evaluator to the meet to provide Officials the opportunity for advancement or recertification of their National level officiating certifications. Qualifying meets are

- Long Course Senior Zone Championship
- Long Course Age Group Championship
- Zone Open Water Championship
- Speedo Sectionals Long Course "Super Sectional"
- Short Course Age Group Championship
- Speedo LC Sectionals (Entire Zone)
- Speedo SC Sectionals (North Region)
- Speedo SC Sectionals (South Region)

Travel and lodging receipts must be provided by the meet host

Cost: Up to \$8,000/year

#### **Background:**

The aforementioned meets have, historically, been OQM meets where Officials from various LSCs advance or recertify their National officiating credentials that allow them to be considered for positions at higher level meets. It has also, historically, been the meet host's responsibility to cover the travel and lodging costs associated with bringing in a National Evaluator to the meet for such purposes. The Niagara LSC has, also, allocated reimbursement money to hosts of these meets over the last four years. With the cost of everything from pool time, to Life Guards, to hospitality food and beverage, etc. continually growing, this proposal aims to give some cost relief to these meet hosts while continuing to provide Officials with a path to higher level meets. Additionally, since Officials from all LSCs within the Zone benefit from these meets, it seems reasonable to include assistance for this expense in the Zone budget.

There are three groups that will benefit from the passage of this proposal:

- Meet Hosts will benefit as the cost of bringing in a National Evaluator will be, at least, partially reimbursed, adding to their bottom line.
- Officials will benefit as their path(s) to higher level certifications will remain intact
- Athletes will benefit by having higher quality officiating at all levels of meets as a result of the National certification process.
